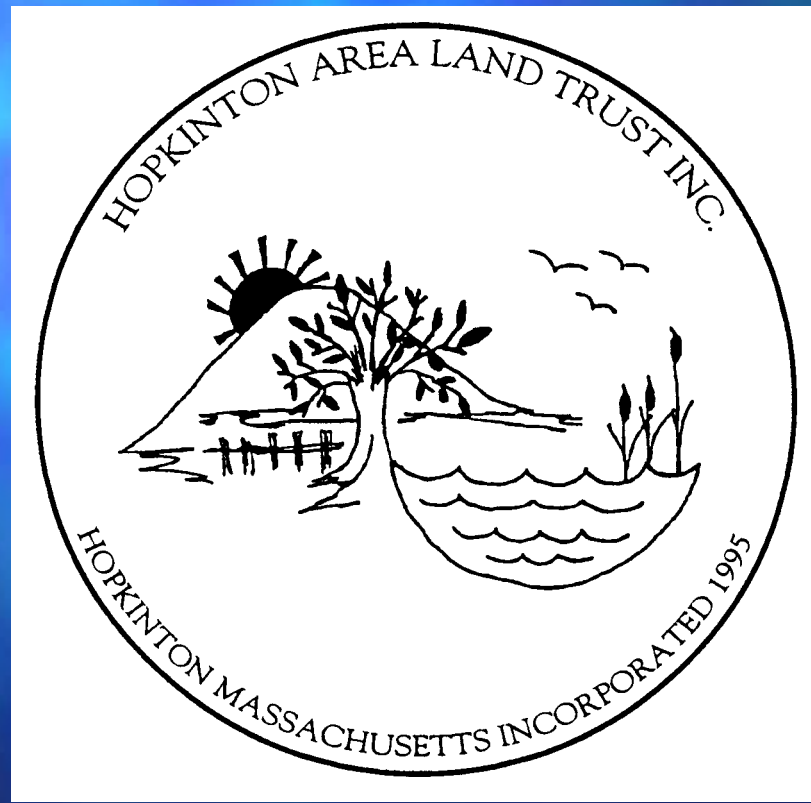

# **Hopkinton Area Land Trust**

## **Goals 1**

---

- **To preserve, protect, conserve, and enhance the natural resources both within and around the Town of Hopkinton Massachusetts, including water resources, marshlands, swamps, woodlands, under-ground water supplies, open spaces, land areas of historical significance and wildlife habitat, in order to maintain and improve the quality of life in the Town of Hopkinton for present and future generations;**

## **Goals 2**

---

- **to educate the public in the area of conservation, ecology, forestry practice, wildlife preservation and land use planning in order to protect open space, plant and animal life therein;**

## **Goals 3**

---

- **to encourage and facilitate the use of land conservation, recreation, and wildlife preservation by cooperating with the Town of Hopkinton, its elected officials and committees, Hopkinton landowners, and other individuals and organizations having similar purposes;**

## Goals 4

---

- to acquire, hold, maintain and enforce such conservation and preservation restrictions, easements and other interest in kind, water areas, and interests as it deems appropriate and in the public interest; and

## **Goals 5**

---

- **generally do all acts and things incidental to, or in furtherance of, the purposes of the Corporation which are permitted under the provisions of Chapter 180 of Massachusetts General Laws and Section 501(c)(3) of the Internal Revenue Service code.**
